111. Kippax Welfare Youth Shelter

a. To receive an update on the removal of the Youth Shelter

LCC have quoted £700 as the cost for removal of the Youth Shelter. The Parish Council have

only approved to spend £100 so alternatives are being explored

112. Kippax Common

a. To receive an update on the Kippax Common project and agree any actions

The plans have yet to be circulated. LCC have provided an estimate of the cost of remarking the MUGA court. **It was resolved** to request a firm quote for full colour markings and recommend to full council approval up to £5,000.

113. Kippax Food Bank

a. To receive an update on the Kippax Food Bank and consider recommendations for full council

Ward Councillors have provided a further grant of £750. A significant reduction in the number of recipients has occurred now that proof of eligibility is required. **It was resolved** to recommend to full council that it is planned to close the food bank on 10th April and this committee will decide what to do with any surplus food supplies at their meeting on 6th April. **It was resolved** to recommend to full council that a further payment is provided to the Band Club for the additional 4 weeks.

114. Promoting walking and cycling

a. To consider how to promote walking and cycling and agree any actions

It was reported that LCC are looking to improve cycle rack provision and are considering putting an additional one at the leisure centre and improving the signposting for the existing ones at the Co-op and Cross Hills, as no cost to the Parish Council. **It was resolved** to also request additional cycle racks at the MUGA and Tennis Courts.

The possibility of producing a smaller cycling guide to supplement the longer walking guide is being considered. It was requested that Councillors bring any proposals on ways to promote walking and cycling in the Parish back for consideration.

115. Community Gala 2021

a. To consider the arrangements for the Community Gala and agree any actions

No further action required at present but will monitor the covid lockdown situation to see if this can go ahead. If it does not it was suggested that an event is planned for the Queens 70th Jubilee celebrations on June 2022.
