It was noted that the PA system could have been better and Councillor M. Biscomb will look into getting a better one. The feedback on the location was good and more events could be held at Cheney Basin in the future.
- b. To received feedback on the Scarecrow Festival and agree any actions.  
The response was very positive with 50 online submissions and the workshop went well. The online map worked better than a set printed map would have. Suggestions for future events were to have it as a separate event, with the public to vote on a theme and for the competition to run throughout the festival with the winner announced at the end. A Halloween trail was also suggested with a prize for the best dressed.
- c. To receive feedback on the Picnic Event and agree any actions.  
It was suggested that more food and hot drinks stalls were needed, and more gazebos would help when weather is not good. It was missing activities for toddlers so need to look at providing more at future events. The car parking and toilets worked well. It was suggested that the Parish Council consider training Councillors to provide first aid, but this would only be suitable for smaller events.

The following actions were agreed:

- To get prices for gazebos for the Parish Council to purchase own.
- To consider repainting the photo backdrop for the Christmas Lights switch-on event
- Councillor M. Biscomb to explore with Breeze what more they can provide in terms of stages, chairs and activities
- To consider incorporating a band stand in the plans for the Common.
- To start the planning for next year's gala in January
