Where are we today?

We are now getting ready for the next phase of construction of the Barnsdale Solar Park, having begun preparatory works last year. We have spent this year completing site investigation works, setting up the community benefit and liaison group, and finalising the site design.

All of this means we now expect to start this phase of construction in July 2025 and begin exporting to the grid when we achieve our Provisional Acceptance Certificate in late 2026.

Ongoing community liaison

A liaison committee has been established which is constituted by the members of the community benefit fund panel which contains local councillors and parish councillors.

In addition to this, we will create a small email based newsletter group for key residents living close to the site to update them as construction takes place, indicating if there will be a high level of traffic movements, as an example. Launching a new community fund

Once the solar farm is complete, we will launch a community fund for the project which will seek applications from local people looking for support for community activities and good causes in the area. A panel of community representatives will agree on funding applications and issue grants for projects nearby that help improve the lives of those living near the project, ranging from enhancing community assets to delivering programs that local people can benefit from individually.

Further details of the fund will be communicated as the panel is established and the guidelines for applications are completed over the summer.





How do we build a solar farm?



Detailed design

Drawing on the findings of site investigation works, this stage is where we agree on the final design, the scope for our main contractors and confirm our requirements for the build

Procurement

Purchasing and delivery of all components for Barnsdale, some of which can have long lead times

Civils

Construction to make the site ready for the arrival of panels themselves. This includes building access tracks, laying foundations for panels and grid infrastructure, digging cable trenches and any other necessary groundworks

Mechanical works

Installation of solar panels and mounts

Electrical works

Installation of electrical infrastructure like cables, inverters and the sub-station

Testing and comissioning

Extensive testing of site components, electrical infrastructure and health & safety procedures which is followed by energisation of the entire site.

Once complete, Barnsdale will be fully operational so will be generating and exporting power to the National Grid

Final site acceptance

A 24 month period of close monitoring to ensure all equipment is performing as per the design, so that any issues are picked up and addressed quickly. This is a standard practice which confirms the actual generation capabilities of the site, a bit like a warranty period
